Dear Parent/ Carer

Re: Meningitis ACWY & 3-in-1 Teenage Booster Vaccination for Year 9 Students

The Berkshire School Age Immunisation Team offer year 9 students the 3-in-1 (tetanus/diphtheria/polio) vaccine alongside the MenACWY vaccine in the spring term. The MenACWY vaccine is a direct replacement for the Men C vaccination.

Tetanus is a serious disease which affects the central nervous system that is caused by bacteria found in soil. The disease is spread through open cuts and wounds.

Diphtheria is a highly contagious and potentially fatal bacterial infection that can affect the nose and throat, and sometimes the skin.

Polio is a serious viral infection that used to be common in the UK and worldwide. It's rare nowadays because it can be prevented with vaccination.

The **MenACWY** vaccine protects against four strains (MenA, MenC, MenW, MenY) of the meningococcal bacteria that cause meningitis and blood poisoning (septicaemia) which can be deadly. The MenACWY vaccine was introduced in 2015 because of the recent increase in cases of MenW disease in the UK.

The vaccine can safely be given at the same time as the 3-in-1 teenage booster vaccine.

Your Child's Personal Information

Immunisation is one of the most successful and cost effective health protection interventions and is a cornerstone of public health. High immunisation rates are key to preventing the spread of infectious disease, complications and possible early death among individuals and protecting the population's health through both individual and herd immunity. Due to the significant impact of immunisations on school aged children and the wider population it is really important that the immunisation team can access and share patient identifiable information (on eligible children) securely. Without this information we would not be able to fully monitor/ report and offer vaccination to all eligible cohorts which could lead to poor public health outcomes.

When you and your child use our services, we'll ask for and record your child's personal and health information to help us treat your child now and in the future. We may share your child's information with other organisations to assist with giving your child the best care possible, only information that is required and appropriate to support your child's care and treatment will be provided. During the autumn term you will receive a consent form for your child to receive their Men ACWY & 3-in-1 vaccinations. The information collected within the consent form will be shared with your child's GP following vaccination so that their health records can be updated accordingly. The consent form will then be stored and archived securely by Berkshire Healthcare Foundation Trust following their Record Keeping Policy.





If you do not want your child to receive the Men ACWY or 3-in-1 vaccinations we would still like you to complete their consent form to indicate this so that we can accurately report numbers of students back to NHS England.

Parent Checklist for Men ACWY & 3in-1 Vaccinations

	<p>Complete consent form (provided in the autumn term)</p> <p>The person with parental responsibility for the child must complete the consent form.</p> <p>SELF CONSENT: What if my son/daughter wants the vaccination, but, as their parents we would rather they didn't have it? If your child wishes to have the vaccine the Nurse will assess their competence to self-consent before making the decision whether or not to administer the vaccine and the decision is legally theirs to make. You should discuss this with your school immunisation team to get further information and advice. 	<p>Contact the Immunisation team if you have any medical queries and ensure that any medical conditions, including severe allergies are documented on the consent form.</p>	
	<p>Return a signed consent form to school as soon as possible after receiving it</p>	
	<p>On the day of immunisation, please let the immunisation team know if your child:</p> <ul style="list-style-type: none"> • Suffering from acute severe febrile illness • Any change to relevant medical conditions 	
	<p>Following vaccination your child (if vaccinated) will have a vaccine record card with details on their vaccinations; including date and time they received it. Please ensure that this is kept safely.</p>	

What to expect on the day of your child's vaccination session

	<p>Consent forms will be issued in advance of the immunisation session. These need to be completed, signed and returned to school as soon as possible so that we can start planning for how many students require vaccination.</p>
	<p>The immunisation team will aim to arrive at your child's school for 9am to set up the session. This will include preparing tables, sorting out equipment and checking vaccines and emergency medication. Some nurses may arrive earlier to allow time to be able to check through all of the returned consent forms – this process includes dealing with any medical queries, removing any non-consent and determining numbers for vaccinating.</p>
	<p>The team aim to start vaccinating at 9:30am and will vaccinate children, usually in class/tutor groups throughout the day.</p>
	<p>Following vaccination all children will be issued a vaccine record card to take home. This card is a record of the vaccine they received and provides information on the specific details of the vaccine and possible side effects.</p> <p>If your child is unwell on the day of the session we will record this on their record card and invite you to make a community clinic appointment as soon as possible (you will receive notification of how to do this).</p> <p>As a service we sign and complete all consent forms for children who have been vaccinated and then notify Child Health who will inform their GP surgery that they have been vaccinated so that their health records can be updated.</p> <p>Any absent children who have returned (signed) consent forms requesting the vaccine will be sent recall letters inviting them to a community clinic.</p> <p><u>Please note</u> if you do not return a consent form for your child you will receive a letter/call to book into a community catch up clinic.</p>

Preparing Your Child For Their Men ACWY & 3in-1 Vaccinations

With the exception of students whose parents/carers previously declined the vaccination most children who consent to the 3-in1 vaccination would have received this vaccine previously when they were younger.

3-in-1 vaccination – how many booster do I need?

Students will need a total of **five** doses of **tetanus, diphtheria** and **polio** vaccines to build up and keep their immunity. Students should have had:

- the first three doses as a baby
- the fourth dose when you were between three and five years old, before you started school, and [4-in-1 \(DTaP/IPV\) pre-school booster](#)
- the fifth dose is due in year 9 (aged 14)

Having **FIVE** doses of tetanus should be enough to give the student long-term protection from tetanus. However, if the student is not sure how many doses they've received, they may need a booster dose after an injury that breaks the skin.

If I was immunised against tetanus, diphtheria, polio infection as a child, am I still protected?

You may still have some protection, but you need these boosters to complete your routine immunisations and give you longer-term protection.

MenACWY vaccination – students only require one vaccination. Students eligible for the MenACWY vaccine should have it, even if they've previously had the MenC vaccine.

Side Effects

Like all vaccines, the MenACWY vaccine can cause side effects, but they are generally mild and soon settle down. The most common side effects seen in teenagers and young people are redness, hardening and itching at the injection site, fever, headache, nausea and fatigue. These symptoms should last no more than 24 hours. Sometimes, a small, painless lump develops, but this usually disappears in a few weeks.
